Title: Main - Ganshyn #170

On 06/28/2026 around 1152 hours I received a FLOCK automated license reader alert for a stolen license plate from New Jersey 34DTM. I ran NJ 34DTM in NCIC and learned that it was a lost manufacturer's plate that was reported by Los Angeles PD. The vehicle bearing the plate appeared to be silver/gold colored Land Rover SUV. The vehicle was seen going northbound on Vinewood Ln N from Rockford Rd.

I responded to the area and located the vehicle parked in front of Kohl's store at 4190 Vinewood Ln N. The vehicle was unoccupied and had no front plate. Together with other officers, I stayed in the area until the driver returned to the vehicle. I observed the driver, who was a white male wearing shorts and a green shirt, as he was putting something in the back seat of the car. I could also see a white female getting into the front passenger seat. When the driver started getting into the driver's seat, officers initiated a box and pin on the vehicle.

Both the driver and the passenger were cooperative and exited the vehicle without issue. Driver was identified as Joel Feder, the female passenger was his wife, Karen Feder. Joel explained to me that he is the Director of Content and Product for The Drive, a digital media platform that covers and reviews automotive industry.

Joel explained that he received the vehicle about a week ago for a review from the fleet management agency. The vehicle came from Illinois and was going back the next Monday, 06/29/2026. While on scene, Joel contacted the fleet management agency, who in turn provided contact for Jaguar Land Rover North America LLC. I spoke to [REDACTED] the Press Fleet Manager of the company.

[REDACTED] explained to me that press fleet vehicles use New Jersey manufacturer's plates. Such plate numbers contain four numbers, followed by three letters. The first two digits are full size, while the second two digits appear smaller on the plate. One of the fleet vehicles, bearing NJ 34(03)DTM, was used in a photo shoot in Los Angeles. During the photo shoot, that plate for the vehicle was misplaced. The corporation had to report the plate as lost to the law enforcement. The plate was reported as NJ 34DTM instead of NJ 3403DTM. The vehicle that Joel was driving was bearing NJ 34(10)DTM. [REDACTED] was advised to contact LAPD and correct the mistake.

Joel and Karen were given the case number and advised not to drive the vehicle until it will be picked up by the fleet employees on 06/29/2026.
